General Information for Requesting a Dependency Status Override

A student who does not meet the federal criteria for independent status on the 2023-2024 Free Application for Federal Student Aid (FAFSA) may submit this form and supporting documentation for a determination if unusual circumstances exist for granting a dependency status override. The Higher Education Act allows a financial aid administrator to make dependency overrides on a case-by-case basis for students with unusual circumstances.

Note: Parents refusal or unwillingness to contribute to your education; and/or student financial independence are not considered extenuating circumstances. Unusual circumstances do include an abusive family environment or abandonment by parents. Complete this form based on your relationship with your biological or legal parent(s). Due to the sensitive nature of this type of information, please be assured that any information you share with Cabrini University's Office of Financial Aid will remain confidential.
